4.1.2 如验收前发生故障，需维修后方可验收，同时供应商应书面承诺保修期如发生同样故障时，将免费维修，对于同一部位出现 2 次以上故障，双方协商后续维修方案。

4.1.3 保修期内软硬件出现问题，应在接到用户通知后 8 小时内响应，如有必要工程师须在 2 个工作日内到达现场进行维修。

4.1.4 仪器发生重大问题或其他无法立刻解决的问题应在一周内解决或提出明确解决方案，质保期内开机率达到 90%，如果停机时间超过 10%，则顺延超出部分的时间。

4.2 软件升级

软件升级：在硬件支持的前提下，应用软件终生免费升级。

保修期过后，供货方应继续提供终生应用技术支持和维修服务，并承诺保证不短于 10 年的零配件供应。

4.3 资料

供应商能够提供的全部技术资料，包括合同签订后提供设备的预安装要求说明书；随机

提供产品使用说明书和维护说明书。

5.供货及售后服务要求

5.1 包装要求：应使用崭新坚固之木箱（标准出口包装），适合于空运、海运或陆运等长途运输方式；适合气候变化；抗震、防潮、防雨、防锈、防冻。投标商应对任何由于不当包装或防护措施不利而导致的商品损坏、损失、锈蚀、费用增长等后果负责；

5.2 货物抵达目的地港口/机场后至华东理工大学的运输和保险费用由中标方承担（清关费用由买方承担）。

5.3 提供的产品须为原装正品，相关配套附件质量优良，数量齐全。

5.4 投标方需注明仪器设备的免费上门质保期限和具体的维修保障内容，及质保期满后，应提供终身上门维护；

5.5 招标方使用该设备的任何一部分，当受第三方提出的侵犯其专利权、商标权或工业设计权的投诉时，由投标方承担相应责任。

5.6 其他：针对进口的投标产品，若中标后由于贸易摩擦等原因需对部分产品加征关税，则加征部分的税金由双方协商解决。

*5.7 合同签订后 60 天内，由买方开立以卖方为收益人的 100% 经卖方确认的不可撤销信用证，其中合同总价的 90%，凭货物发运单据议付；最终验收合格后 30 天内，最终验收合格后 30 天内，在收到中标人出具的 2% 的银行质量保证金保函（保函的有效期为验收合格后的一年）后支付合同总价的 10%。
